

# **NOTICE OF A COMPLETE APPLICATION AND PUBLIC MEETING TO CONSIDER A PROPOSED ZONING BY-LAW AMENDMENT AND A PROPOSED DRAFT PLAN OF SUBDIVISION**

**TAKE NOTICE** that the Township of Centre Wellington has received a complete application (File No. RZ02/18) for approval of a zoning by-law amendment pursuant to Section 34 of the Planning Act, R.S.O. 1990. The County of Wellington has received an application for draft plan of subdivision 23T-17002 and has requested that the Township of Centre Wellington hold a public meeting. The Council of the Township of Centre Wellington will hold a public meeting regarding these applications on Monday March 26<sup>th</sup>, 2018 in the Council Chamber, 1 MacDonald Square, Elora at 6:30 p.m. The purpose of the public meeting is to present the proposed zoning by-law amendment and draft plan of subdivision and to receive public input prior to making a decision.

## **Purpose and Effect**

The subject land is shown on the key plan below. The purpose and effect of the proposed zoning amendment is to change the zoning from Residential (R1B(H), R1C(H), R2(H), R3(H)) and Open Space (OS) to Residential (R1B, R1C, R1C Exception, R2, R2 Exception, R3, R3 Exception, R4 Exception) and Open Space (OS) in order to accommodate the development of a proposed draft plan of subdivision. The proposed draft plan of subdivision consists of lots and blocks for up to 152 single detached, semi-detached and townhouse dwelling units, parks, storm water management pond and walkways.

## **Oral or Written Submissions regarding the Draft Plan of Subdivision and Zoning By-law Amendment**

Any person or public body is entitled to attend the public meeting and make written or oral submissions in support of or in opposition to the proposed zoning by-law amendment. ## **Requirements for Owners of Multi-tenanted Buildings**

Upon receiving this Notice, owners of multi-tenant buildings with seven (7) or more residential units are required under the Planning Act to post this Notice of Public Meeting in a location that is clearly visible to all tenants (i.e. building or community notice board). The Notice shall remain posted until March 27, 2018 (the date after the Public Meeting).

## **Notice of Passing**

If you wish to be notified of the decision of the Township of Centre Wellington in respect of the proposed zoning by-law amendment, you must make a written request to the Clerk of the Township of Centre Wellington, 1 MacDonald Square, Elora, Ontario, N0B 1S0.

## Notice of Decision

If you wish to be notified of the decision of the County of Wellington in respect of the proposed draft plan of subdivision, you must make a written request to the Director, Planning and Development Department, County of Wellington, 74 Woolwich Street, Guelph, Ontario, N1H 3T9. If you wish to be notified of the passing of the proposed zoning by-law amendment by the Township, you must make a written request to the Clerk of the Township of Centre Wellington at the address shown below.

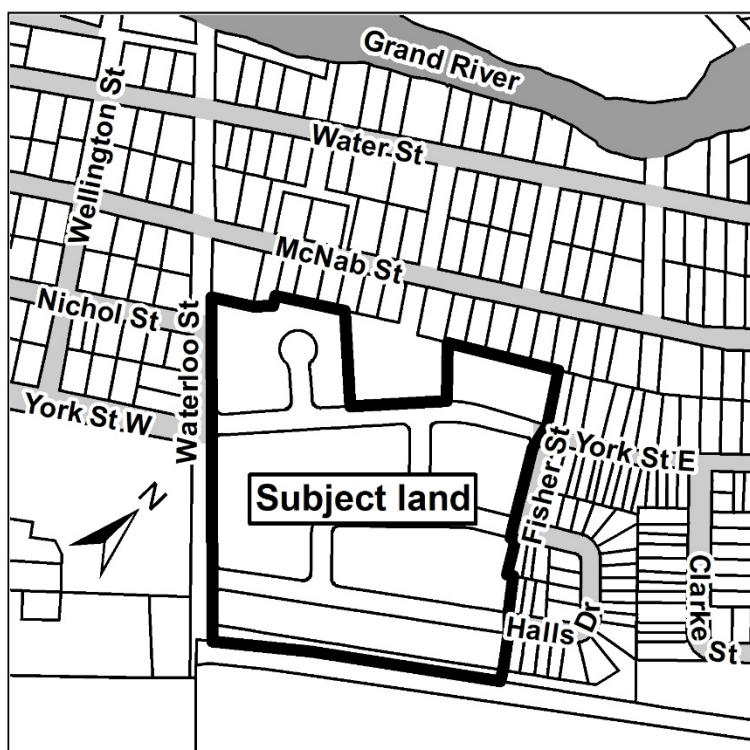
## Right to Appeal

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Centre Wellington before the by-law is passed, the person or public body is not entitled to appeal the decision of Council of the Township of Centre Wellington to the Ontario Municipal Board. If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Centre Wellington before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.

If a person or public body does not make oral submissions at the public meeting or make written submissions to the County of Wellington in respect of the proposed plan of subdivision before the County of Wellington gives or refuses to give approval to the draft plan of subdivision, the person or public body is not entitled to appeal the decision of the County of Wellington to the Ontario Municipal Board. If a person or public body does not make oral submissions at the public meeting, or make written submissions to the County of Wellington in respect of the proposed plan of subdivision before the County of Wellington gives or refuses to give approval to the draft plan of subdivision, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Municipal Board unless, in the opinion of the Board, there are reasonable grounds to do so.
