## Water Supply Master Plan / Class Environmental Assessment Notice of Second Public Information Centre

### Background

The Township of Centre Wellington is creating a Water Supply Master Plan (Master Plan) to define where and how we will continue to provide safe and reliable water from now until 2041. Since early 2018, we have been reviewing water demand projections and existing water supply capacity, reviewing water conservation options, and exploring future water supply alternatives. We are now seeking input from the community on the evaluation of the water supply alternatives in order to confirm the preferred alternatives.

### The Process

Our study is following the requirements of Phases 1 & 2 of the Municipal Class Environmental Assessment (Class EA) in accordance with Approach #1 of the Master Plan Process described in the Municipal Class Environmental Assessment by the Municipal Engineers Association. When we're done – after our Master Plan is reviewed by the community and approved by Township Council – we will have evaluated and prioritized a number of priority Class EA projects and developed an implementation strategy that will ensure the continuation of the safe and reliable water supply services we provide to the community.
