### AQUATIC INSTRUCTORS, GUARDS AND AQUAFIT INSTRUCTORS

The Township of Centre Wellington's Community Services Department is now accepting applications from qualified candidates for the positions of Aquatic Instructors, Aquatic Guards and Aquafit Instructors, at the Centre Wellington Community Sportsplex.

The Township is offering all required courses for positions this summer. Candidates interested in applying without all of their certifications are welcome to do so and positions can be offered based on the successful completion of the required courses.

**Assistant Instructor Guard (AIG):** Assist the instructor during the instructional program. Perform minor first aid and assist in emergencies as required. Represents the Township of Centre Wellington in a consistent, positive manner, through ownership of programs, facility and meeting customer service expectations.

**Qualifications:** Minimum requirement – Red Cross Water Safety Instructor (WSI), Bronze Cross

**Swim Instructor:** Instruct assigned classes in accordance to the governing body's (Red Cross, Lifesaving Society standards and the Township of Centre Wellington expectations. Represents the Township of Centre Wellington in a consistent, positive manner, through ownership of program, facility and meeting customer service expectations.

**Qualifications:** Minimum requirement – National Lifeguard, Red Cross Water Safety instructor, Standard First Aid, CPR "C" all current within 2 years

**Lifeguard:** Maintain and enforce high safety standards at all times. Lifeguard as requested and assume all responsibilities of a guard. Represents the Township of Centre Wellington in a consistent, positive manner, through ownership of programs, facility and meeting customer service expectations.

**Qualifications:** Minimum requirement – National Lifeguard, Red Cross instructors, Standard First Aid, CPR "C" all current within 2 years

**Aquafit Instructor:** Instruct assigned classes in accordance to the governing body's (WaterArt, CALA standards and the Township of Centre Wellington expectations. Represents the Township of Centre Wellington in a consistent, positive manner, through ownership of program, facility and meeting customer service expectations.

**Qualifications:** Minimum requirement – Aquafit Certification from a Nationally recognized provider (ie WaterArt, CALA, YMCA) current within 2 years
