

## **TOWNSHIP OF CENTRE WELLINGTON NOTICE OF COMPLETE APPLICATION REGARDING A PROPOSED ZONING BY-LAW AMENDMENT**

**TAKE NOTICE** that the Township of Centre Wellington has received a complete application for a zoning by-law amendment pursuant to Section 34 of the Planning Act, R.S.O. 1990. The Township's file number for this application is **RZ002-2026**. The subject lands are known municipally as 5999 Eighth Line East, 6043 Eighth Line East and 7190 Sideroad 22, Pilkington, as shown on the key map below.

### **Purpose and Effect**

The purpose of the proposed zoning by-law amendment is to change the zoning from "A" Agricultural and "EP" Environmental Protection to "M3-XX" Extractive Industrial Exception and "EP" Environmental Protection. The effect of the amendment is to permit the establishment and operation of a licensed aggregate extraction operation (gravel pit).

### **Related Application**

The applicant has filed an official plan amendment with the County of Wellington. The file number for this application is **OP-2025-15**.

### **Requirements for Owners of Multi-tenanted Buildings**

Upon receiving this notice, owners of multi-tenant buildings with seven (7) or more residential units are required under the Planning Act to post this Notice of Public Meeting in a location that is clearly visible to all tenants (i.e. building or community notice board).

### **Notice of Passing**

If you wish to be notified of the decision of the Township of Centre Wellington in respect of the proposed zoning by-law amendment, you must make a written request to the Clerk of the Township of Centre Wellington, 1 MacDonald Square, Elora, Ontario, N0B 1S0 or email: [kokane@centrewellington.ca](mailto:kokane@centrewellington.ca).

### **Appeal Rights**

TAKE NOTICE that if a person or public body would otherwise have an ability to appeal the decision of the Township of Centre Wellington to the Ontario Land Tribunal (OLT) but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Centre Wellington before the by-law is passed, the person or public body is not entitled to appeal the decision.

AND TAKE NOTICE that if a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Centre Wellington before the by-law is passed, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Tribunal, there are reasonable grounds to do so.

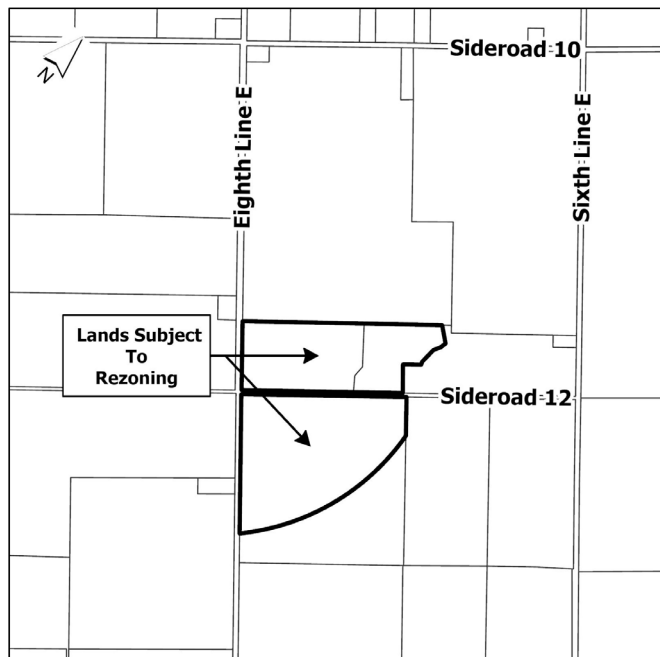
