


Notice of Passing

If you wish to be notified of the decision of the Township of Centre Wellington in respect of the proposed Official Plan Amendment or Zoning By-law Amendment, you must make a written request to the Municipal Clerk of the Township of Centre Wellington, 1 MacDonald Square, Elora, Ontario, N0B 1S0.

If the Official Plan Amendment is adopted, it will be forwarded to the County of Wellington for approval. If you wish to be notified of the decision of the County of Wellington in respect of the proposed Official Plan Amendment, you must make a written request to the Director, Planning and Development Department, County of Wellington, 74 Woolwich Street, Guelph, Ontario, N1H 3T9

Appeal Rights

If a person or public body would otherwise have an ability to appeal the decision of the County of Wellington to the Ontario Land Tribunal (OLT) but the person or public body does not make oral submissions at a public meeting or make written submissions to the Township of Centre Wellington before the By-law is passed or before the Official Plan Amendment is adopted, the person or public body is not entitled to appeal the decision.

If a person or public body does not make oral submissions at a public meeting, or make written submissions to the Township of Centre Wellington before the By-law is passed or before proposed Official Plan Amendment is adopted, the person or public body may not be added as a party to the hearing of an appeal before the Ontario Land Tribunal (OLT) unless, in the opinion of the Tribunal, there are reasonable grounds to add the person or public body as a party.



How to Stay Informed

If you wish to be notified of the decision of the Township of Centre Wellington in respect of the proposed zoning by-law amendment, you must make a written request to the Municipal Clerk at the address above.
