Where Township Council refuses consent to demolish of remove a building or structure on the property the decision of Council is final. The owner shall not demolish or remove the building or structure or do any work or cause or permit any work to be done to demolish or removal or the building or structure or any part or it, unless, the owner has obtained a Building Permit to erect new building on the site of the building or structure sought to be demolished of removed AND 180 days have elapsed from the date of the Council's decision to refuse the application.
